REGISTRATION FEE	\$ 300.00 (non-refundable)	
MATERIAL FEE	\$250.00	TK/ Kindergarten
	\$275.00	Grades 1 and 2
	\$325.00	Grade 3
TUITION FEE	Kindergarten (7am – 6pm)	\$ 1100.00 per month
	Grades 1 to 3	\$1150.00 per month
	<b>Part time program is only for TK and not for Kindergarten</b>	
	4 Days	\$ 900.00 per month
	3 Days	\$ 800.00 per month
	2 Days	\$ 600.00 per month
	Daily Fee	\$60.00 per Day
LATE CHARGE	\$20.00 must be included on payments made after the 10 <sup>th</sup> of the month. Tuition is due on the 1 <sup>st</sup> of the month.	
RETURN CHECKS	\$20.00 will be charged on the return checks. If a check gets returned after the 20 <sup>th</sup> of the month the late fee too must be paid.	
TO ENROLL	The registration fee, first month tuition, and the material fee must be paid by the first day of school. <b><i>Withdrawal from school requires 2 weeks written notice from 1<sup>st</sup> to the 15<sup>th</sup> or 15<sup>th</sup> to the 31<sup>st</sup> of each month or 2 weeks tuition in lieu of such. Tuition credit cannot be given for miscellaneous absences from the school, vacations taken during the school year and for early withdrawal in the month of June.</i></b>	
SCHOOL HOURS	The school opens at 7:00 a.m. and closes sharp at 6:00 p.m. <b>PARENTS MUST GIVE THEMSELVES SUFFICIENT TIME TO PICK UP CHILDREN AND THEIR BELONGINGS IN ORDER FOR OUR STAFF TO CLOSE AT SIX.</b>	
LATE PICK UP	Pick up after 6:00 p.m. is charged at <b><u>\$60.00 per hour (\$1.00 per minute)/per child.</u></b>	

Any payments in arrears of forty-five days may be sent for collection. All legal and other charges incurred in collecting overdue accounts will be charged to the parents.
